Who is covered

All PaddleNSW registered members & Clubs who have sought, paid for and received an independent Pleasurecraft Insurance Policy issued directly through OAMPS Insurance Brokers.

Or any PaddleNSW registered member who has sought Pleasurecraft Insurance through their affiliated PaddleNSW club and has received a schedule of insurance confirming indemnity on their pleasurecraft.

What are the Benefits

The PaddleNSW Pleasurecraft Insurance Scheme has been developed exclusively for its members and provides coverage for:



Accidental Damage
Malicious Damage

Whilst Racing, Training and Private use
Whilst in Transit
Whilst in Storage

(Pleasurecraft would be excluded under most domestic home contents insurance policies).

Sum Insured

Market Value – Means the sale value of the Boat immediately prior to the claimed loss or damage taking into account the condition of the boat, but only ever to the maximum of the sum insured shown on the schedule, whichever is the lesser.

Additional Benefits of the OAMPS / Club Marine Pleasurecraft Insurance policy are not insured under this program.

To assist us to process your claim, please also provide the following information/documentation:

- Quotation for repairs/replacement.
- Photographs of damage
- Repairers report

Other aspects to be aware of:

- Take all reasonable steps to prevent any further loss from occurring.
- Advise the nearest police station if your property is lost or stolen, vandalised or maliciously damaged.
Your Insurer may ask you to give us a written report from the police.
- Retain the property that has been damaged so that your Insurer can inspect it if required.
