## PADDLE NEW SOUTH WALES INC MEMBERSHIP APPLICATION

### Terms and Conditions of Category 2 (Club) Membership of Paddle New South Wales Incorporated

In applying and in consideration of my application for membership being accepted I **acknowledge and agree** that:

1. **"PNSWI"** for the purposes of this membership application and declaration means and includes Paddle New South Wales Incorporated, its members (including Member Clubs) and where the context so permits, that club's directors, officers, members, servants or agents.
2. **'My Club'**, for the purposes of this application, means the club which I represent as applicant.
3. **I, the applicant**, hold the position of **president, vice-president or secretary** of my club at the time of this application for membership of PNSW
4. **If accepted my club will be a member** of PNSWI.
5. **This document cannot be amended.** If amended or altered in any way, my application will be null and void.
6. **The PNSWI Constitution** is a contract between my club and PNSWI. My club acknowledges and agrees to comply with the Constitutions and By-Laws of PNSWI. I will ensure that every participant in the club's events is a PNSWI member, and has either full membership or single event membership.
7. **Insurance** is in place that provides limited cover to my club whilst it is performing or conducting any authorised or recognised club activity ("**PNSWI Category 2 Club Member Activity**"). (*For insurance details contact PNSWI*.) My club can, in its own interests, seek and obtain additional insurances over and above the cover provided by PNSWI.
8. **Warning:** Paddling can be inherently dangerous. Serious accidents can and do happen which may result in my club members being injured or even killed. I have voluntarily read and understood this warning and accept and assume the duty of care pursuant with the obligations of my club management.
9. **Exclusion of Liability:** Except where provided or required by law and such cannot be excluded, I agree that it is a term of my club's membership (if accepted) that PNSWI is absolved from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my club's membership and/or participation in any PNSWI Activity.
10. **Release and Indemnity:** In consideration of PNSWI accepting my club's application for membership:
  - (a) My club releases and forever discharges PNSWI from all Claims that it may have or may have had but for this release arising from or in connection with my club's membership and/or participation in any PNSWI Activity; and
  - (b) My club indemnifies and holds harmless PNSWI to the extent permitted by law in respect of any Claim by any person including but not only another Member of PNSWI arising as a result of or in connection with my club's membership and/or participation in any PNSWI Activity. In this **clause 8 "Claims"** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc made by any person entitled to make a claim under a relevant PNSWI insurance policy or under the PNSWI Constitution or any By-Laws.
11. **I have provided the information required on behalf of my club.** I warrant that all information provided is true and correct.
12. **Privacy:** I understand that the information I have provided elsewhere in the membership application is necessary for the Objects of PNSWI. I acknowledge and agree that the information disclosed by me to PNSWI will only be used for the Objects of PNSWI and to provide my club with membership services. I understand that I will be able to access my club's information directly from PNSWI. If the information is not provided my club's membership application may be rejected.

I acknowledge that PNSWI may also use my club's personal information for the purposes of providing my club with promotional material from PNSWI sponsors or third parties. I may advise PNSWI if I do not wish to receive from PNSWI, any PNSWI sponsors, or third parties promotional material.
